- Contract of Employment with photocopy
- Sponsorship letter from India
- Guarantee letter from the local Company

TOURIST VISA

- Passport valid up to 6 months
- Air ticket or Booking Confirmation

BUSINESS VISA

- Invitation letter from India
- Original sponsorship letter or employment certificate from the Local Company

LONG TERM VISA (1-5 years)

- **For Persons of Indian origin:**
Copy of previous Indian Passport or Indian passport of his/her parent(s) in case applicant has never held an Indian passport
- **Filipino married to Indian national:**
Marriage Certificate
Indian Passport (Spouse's name should be included in the Indian national's passport)
- **Filipino one of whose parents is Indian national:**
Birth Certificate
Indian passport of the parents

STUDENT VISA

- Admission letter from the recognized Educational Institution in India
- Satisfactory evidence of Financial Support
- Passport of sufficient validity to cover period of studies

TRANSIT VISA TO OTHERS

- Passport valid up to 6 months
- Confirmed ticket for onward journey

EMPLOYMENT

- Contract of Employment (original with photocopy)
- Letter from the employer justifying the appointment of a foreigner
